## **POINT OF ORDER**

Whereas MCA 13-37-127 states

A candidate for an elective office may not assume the powers and duties of that office until the candidate has received a certificate of election as provided by law. A certificate of election may only be issued by the public official responsible for issuing a certificate or commission of election:

Whereas MCA 13-15-406 states

Certificates to be issued by the election administrator. The election administrator shall, except as provided in 13-37-127, deliver a certificate of nomination or election to each individual declared elected by the board.

Whereas Cascade County has indicated, by letter to Ms. Putnam, the county is waiting to certify the election.

Whereas the document presented as evidence of Mr. Lankford's election was not intended by Cascade County to be a legal notification of election;

Mr. Lankford may not be entered onto the rolls of this meeting.
